I. General overview

At its 9th Ordinary General Meeting (OGM) in Zagreb, Croatia, 29 June 2017, ESEH elected new Board Members and five new Regional representatives. At the meeting of the Council of Regional Representatives (CRR) the same day, five Regional Representatives were elected onto the Board. Because the Regional Representative for Italy was not voted in at the OGM in Zagreb, the Board appointed an interim RR for Italy in 2018.

In the conference year 2017, the income of ESEH was larger than in previous years because the Board replaced many tasks of a professional conference organizer – otherwise provided by the university administration - with a turnover of more than 84,000 Euro. This effort was rewarded not only with 1,500 Euro from the final surplus, but also an increase of membership fees in connection with conference payments via PayPal. Moreover, 1,000 Euro were donated to support the Turku Prize in the 2020s. Expenditures amounted to ca. 13,000 Euro, mostly for conference and summer school in Croatia, whereas high income of over 18,000 Euro led to an increase of capital by over 5,000 Euro.

In such a good state, expenditures in 2018 have been increased for funding 2 workshops, 1 summer school plus 2 archival travel grants with 500 Euro each, 1 more grant could not be collected before the end of the year. Although income decreased in this non-conference year to 4,000 Euro, the financial means still improved in order to secure prizes, travel aids and grants for the 10th ESEH conference in the following year.

III. Presidential report

Between 2017 and 2019, ESEH focused its activities around six areas: 1) support for next generation scholars, 2) support for scholarly development, 3) biennial conferences, 4) recognition of outstanding scholarship, 5) communication, and 6) members, networks and regions. This report provides details for each of these areas.

1) Support for next generation scholars

It is now traditional for ESEH to co-sponsor the organization of European Summer Schools on environmental history with 500 EUR per event. We co-sponsored the Summer Schoool "An Environmental History of the First World War" held at the Centre International de Recherche de l'Historial de la Grande Guerre, in Péronne, France on 2-7 July 2018. The second co-sponsored Summer School in connection with the 10th Biennial Conference was going to be held in Tartu, Estonia in 2019, but unfortunately this event was cancelled by the organizers shortly before the actual event was going to take place. A further means of supporting the next generation of European environmental historians is through ESEH's travel grant scheme. Travel grants support scholars who need financial assistance to attend the biennial conference. For the 2019 Conference in Tallinn we received 29 travel grant applications, of which 28 were awarded a travel grant. The average amount granted was 285 EUR, totalling 8000 EUR. A different grant scheme, ESEH's recently established research grants assist outstanding doctoral students and recent PhD graduates to complete their research in environmental history. ESEH awards up to two grants per year, each 500 EUR. The awardees for 2018 were Jayne Regan, Australian National University: "'A Wealth of Romance': Conservation and commercialism on the Great Barrier Reef, 1885-1970", and Patrick J Klinger, University of Kansas: "The climate of union: An environmental history of the Anglo-Scottish Union of 1707". Research grants for 2019 went to Katrin Kleeman, Ludwig Maximilians University/Rachel Carson Center, Munich: "A Mist Connection: The Icelandic Laki Fissure Eruption of 1783" and Anna Varfolomeeva, Central European University, Budapest: "The narratives of hardship and glory: gender dimensions of stoneworking in Northwestern Russia." In order to strengthen the presence and influence of next generation scholars in environmental history in Europe and beyond, the Board decided to establish the ESEH Next Generation Action Team (NEXTGATe) in 2018. The main activities of NEXTGATe include active social media presence and exploring new ways of scholarly communication. For example, prior to the Tallinn Conference, NEXTGATe members organized a successful Twitter conference. NEXTGATe also organized on-site activities and networking at the conference, including the highly popular ESEH Next Generation Action Team Pub Night, where next generation scholars could meet and mingle in a relaxed atmosphere. NEXTGATe also initiated the ESEH Dissertation database, which in late 2019 included 30 unpublished dissertations on environmental historical topics. More on the activities of NEXTGATe can be found in the 2018/4 Notepad section of the journal *Environment and History*.

2) Scholarly development

ESEH supports with 500 EUR each up to 2 small workshops per year (with less than 100 participants) organized by an ESEH member on any topic in European environmental history. Applications are administered through an open call and decisions are made by the Board. In 2017-2019, the following workshops were selected for support:

- "Conference for Environmental History 2019. Environmental History Events in the Mirror of Historical and Natural Sources in the Carpathian-Balkan Region during the Past Five Millennia." 29–30 October 2019, Eötvös Loránd University, Budapest, Hungary.

Furthermore, the ESEH Board decided to endorse (without financial support) the workshop "Middle Eastern Animals: Interdisciplinary Perspectives from Early Modern to Contemporary Times" held on 27-28 June 2019, at the University of Vienna, Austria.

ESEH has continued its successful cooperation with Berghahn to publish the series Environment in History: International Perspectives. Six volumes were published in 2018-2019:

- Hazardous Chemicals: Agents of Risk and Change, 1800-2000. Edited by Ernst Homburg and Elisabeth Vaupel.

3) Biennial conferences

The 10th Biennial Conference of ESEH was held in Tallinn, Estonia, on 21-25 August 2019. The conference was exceptionally well-organized and many thanks are due to the Local Organizing Committee, especially to Ulrike Plath, Kati Lindström, Linda Kaljundi and Kadri Tüür. The Scientific Committee received 219 individual paper submissions, 73 session proposals, 16 roundtable proposals, 10 special session proposals and 21 poster proposals. Of these, 176 individual papers, 69 sessions, 10 roundtables, 7 special sessions and 21 posters were accepted. In all, the conference was attended by ca. 500 scholars from all over the world. An open call for expression of interest was published by the Board for potential organizers of the 11th Biennial Conference in 2021. Two proposals were received (by the University of Szeged, Hungary and the University of Bristol, UK.) Based on the evaluation of the Conference

Site Selection Committee and the subsequent recommendation of the Board, the CRR selected Bristol, UK, as the site of the 2021 ESEH Biennial Conference.

4) Recognition of outstanding scholarship

Currently ESEH has four different prizes to recognize and promote outstanding scholarship in European Environmental History.

The St Andrews Article Prize (which comes with 500 EUR) rewards innovative and well-written article-length research in any European language published in 2017 or 2018 on any subject in the field of European environmental history, including Europe's (post)colonial impact on the global environment. The Article Prize Committee received 26 submissions. The Prize was won by a multi-author paper: Hartman, Steven, Ogilvie, A.E.J., Ingimundarson, Jón Haukur, Dugmore, A.J., Hambrecht, George and McGovern, T.H. "Medieval Iceland, Greenland, and the New Human Condition: A case study in integrated environmental humanities." *Global and Planetary Change* 156 (2017): 123–139. An honorary mention was awarded to Tim Soens for his article "Resilient societies, vulnerable people: Coping with North Sea floods before 1800." *Past and Present* 241 (2018): 143–177. For the first time, a scientific cartoon for the winning article was prepared by Tomasz Samojlik, which will be available on the ESEH website.

The Turku Book Prize is managed in cooperation with the Rachel Carson Center in Munich, Germany. The Prize (with 3000 EUR) identifies and encourages excellent, innovative, and well-written scholarship in the field of European environmental history. The Book Prize Committee received 31 submissions, of which five were shortlisted. The Book Prize was awarded to Sarah R. Hamilton, *Cultivating Nature: The Conservation of a Valencian Working Landscape*, University of Washington Press, 2018. The following books were shortlisted: Dominik Collet, *Die doppelte Katastrophe: Klima und Kultur in europäischen Hungerkrise 1700-1772*, Vandenhoeck & Rupprecht, 2019. Deborah Coen, *Climate in Motion: Science, Empire and the Problem of Scale*, University of Chicago Press, 2018. Dario Gaggio, *The Shaping of Tuscany: Landscape and Society between Tradition and Modernity*, Cambridge University Press, 2017. Paul Warde, *The Invention of Sustainability: Nature and Destiny, c.1500-1870*, Cambridge University Press, 2018.

ESEH also has the Environment and History Best Poster Prize in cooperation with the White Horse Press to encourage and elevate the status of poster presentations at the biennial conferences. First and second prizes are awarded (100 EUR and 50 EUR, respectively). At the Tallinn conference, the first prize was won by Dimitri van Limbergen for his poster "Back to the roots: Agroforestry and the rediscovery of Roman viticulture (200BC–AD200)." Nina Schläfli won the second prize for her poster "Shipping on the border: Environmental dimensions in the development of steam navigation in the Lake Constance region."

Acting on the initiative of NEXTGATe, the ESEH Board decided to establish a new prize for the best dissertation in European environmental history. Following ESEH tradition, the prize was named after an important location in the history of our society: Tallinn. The Prize aims at supporting early career scholars based in Europe or based outside Europe but working on a European topic. It is intended to enhance the visibility of PhD students and post-docs in environmental history and the environmental humanities, and to strengthen intergenerational ties within the ESEH. A crowdsourcing campaign was initiated to sponsor

financing. 19 donors gave altogether 810 EUR. The Best Dissertation Prize Committee received 35 submissions. They decided to award a joint first prize to two dissertations: Omer Aloni: "Back to the League of Nations — Evaluation of the Environmental Regime: 1919-1939" and Pierre-Etienne Stockland: "Statecraft ad Insect Economies in the Global French Enlightenment (1670-1815)." A special mention was given to John Emrys Morgan for his dissertation: "Flooding in Early Modern England: Cultures of Coping in Gloucestershire and Lincolnshire."

5) Communication

The ESEH website (www.eseh.org) was managed by the Vice-President Wilko Graf von Hardenberg and Secretary Giacomo Parrinello. ESEH also maintained an active presence on social media (facebook and twitter). We continued to publish the ESEH Society Pages (Notepad) in *Environment and History*. Through the efforts of Notepad liaison Marcus Hall, six further overviews of national research in various ESEH regions were published: Poland – 2017/3, Russia – 2017/4, Turkey – 2018/2, Spain – 2018/3, Israel – 2019/1 and Romania – 2019/2. Three Notepads were dedicated to others topics: Zagreb conference reflections: 2018/1, NEXTGATe introduction: 2018/4, ESEH celebrates 20 years: 2019/3. Members continued to receive the presidential newsletter four times a year and extraordinary communication when appropriate.

6) Members, networks, regions

In August 2019, ESEH had 1166 members, a 9% increase when compared to the previous period. ESEH remains a Basic level member of the International Consortium for Environmental History Organizations (ICEHO), which organizes the World Congress of Environmental History every 5 years. The latest WCEH took place in July 2019 in Brazil. ESEH is also a member of the European Alliance for Social Sciences & Humanities (EASSH), which advocates SSH in EU research funding strategies.

It was an important aim of the Board to widen the geographical scope of ESEH. To this end, two entirely new regions were established (Ukraine and North-Macedonia) by the Ordinary General Meeting. Furthermore, the existing regions of Croatia and Serbia were merged and Slovenia (so far not part of ESEH regions) joined in to create the newly established region of Croatia-Serbia-Slovenia.
