I am been a member of various ESEH committees, served as the Regional Representative of the Nordic Countries for four years and organised two environmental history conferences in Turku in 2005 (Nordic meeting) and 2011 (ESEH conference). I have published a number of articles and edited some anthologies on environmental history; the most recent one is "Thinking through the Environment: Green Approaches to Global History" (2011). The volume is a collection offering global perspectives on the intersections of mind and environment across a variety of discourses.

ESEH has been a vivid and dynamic society and the atmosphere of its conferences has been pleasant and multidisciplinary. We should work for preserving ESEH as an energetic society open to new people and fresh ideas. ESEH has launched various kinds of activities, such as biennial conferences, summer schools, publications on paper and online etc. As a vice-president I would like to activate new people with different backgrounds to research and teach environmental history and put special efforts to extend contacts with the countries where environmental history has not yet gained a footing.
