### 1. Opening of the meeting by the President

The meeting was duly and formally opened by the outgoing President, Dolly Jørgensen, at 17:45.

### 2. Minutes of the 7th Ordinary General Meeting, Munich, 23 August 2013

The minutes of the 2013 OGM, available for perusal on the ESEH website, have been approved by raise of hands. No votes were called against.

### 3. President's report on the development of ESEH

The President read her report on the Society's development, which will be included in the ESEH 2013-2015 Biennial Report.

## 4. Report by the Chair of the Council of Regional Representatives

The Chair of the Council of Regional Representatives read his report on the activities of the RRs, which will be included in the ESEH 2013-2015 Biennial Report.

### 5. Treasurer's report on budget 2013-2015

The Treasurer read his report on the 2013-2015 budget, which will be included in detail in the ESEH 2013-2015 Biennial Report.

### 6. Report by the Financial Control Committee

Dominik Collet, representing the Financial Control Committee, communicated that the Committee found only one missing receipt in all of the Treasurer's accounts over the two years. The Treasurer has promised to make that receipt available as soon as he was back home. The FCC asks the assembly to dismiss the Treasurer with a vote of confidence.

### 7. Vote on constitutional amendment

The constitutional amendment proposed by the 2013-2015 ESEH Board asking for the introduction of a new article on how to fill elected positions in case they are vacated in between OGMs was approved with 64 yes votes and 1 abstention. The new constitutional article reads:

"9.7 If a Board member (other than the President) or a Regional Representative resigns for any reason, the Board may appoint a replacement to serve until the next OGM. If the

President resigns for any reason, the Board will vote to fill the President position with one of the Vice-Presidents, who will then serve as a replacement until the next OGM."

### 8. Vote on creation of new region

The institution of the ESEH region Israel, duly required by local members and supported by the exant Board, has been approved with 46 yes votes, 9 no votes, and 11 abstentions.

### 9. Discharge of the outgoing Board Members, Financial Control Committee, and Regional Representatives.

The 2013-2015 ESEH Board was duly discharged.

### 10. Election of the new Board, Financial Control Committee, and Regional Representatives

The elections have run regularly under the supervision of the exant Nomination Committee. The results were as follows:
