#### INTRODUCTION

The Spanish University Network for Environmental History (RUEDHA - Red Universitaria Española de Historia Ambiental), within the HUM952-STAND Research Group has been developing biannual meetings for a long time, in order to promote a continuous dialogue with researchers from the Iberian Peninsula context regarding the work agenda of the Socio-Environmental History. After the last meeting in Granada in 2016, we reconvene researchers who, from many areas and fields, feel called to work in the relationship that human societies and nature have had throughout History. We seek to continue with the existing work agenda but open the space to collaboration with new groups and emerging research topics, so the sessions are led by researchers from these interdisciplinary fields to continue research in the future.

It is time to resume the dialogues and shared knowledges, for which we have organized a meeting in which to work on axes that are emerging in the field of Environmental History, without forgetting elements that have gone through our research in the last two decades.

Faced with the civilizing crisis in which we are immersed, we have to respond to the challenge, in order to find answers to the problems that afflict us. Thinking about "recommunization" of our social practices inevitably leads us to a broad and prospective view of the commons as subjects of social change. The session coordinated by Professor Jose Miguel Lana Berasain (UPNA) will be dedicated to that. Likewise, the energy and material flows between society and the environment, studied through the different tools of the Social Metabolism proposal, will be the central object of the session coordinated by Professor Juan Infante-Amate (UPO). This session will discuss works focusing on different socioeconomic sectors (agricultural, industrial, domestic metabolisms...), addressing different chronological frameworks.

Faced with the global ecological crisis, socio-environmental resistance emerges as a space for the creation of new forms of production *vs.* the impacts of the capitalist system, which arise both from the field of struggle *stricto sensu* and from new forms of memory of the territory. We Re-Exist against the socio-environmental crisis. Crisis that must take us to a historical look at the catastrophic episodes, the impact on the climate, the environmental









risks. This will be attended in the session coordinated by Professor Armando Alberola (University of Alicante). Eventually, the field of extractivism will open the field of work of the session proposed by Professors Luis Sánchez Vazquez (UGR) and Juan Diego Pérez Cebada (University of Huelva). Mining and Environment in constant productive tension will require a careful and deep look at the proposed session.

#### PARALLEL ACTIVITIES

Alongside all this will be enabled spaces for book sales, presentation of specific research materials and other activities related to the field of Environmental History (projection of documentaries, etc.). Works in progress...
